## **GLOBAL EXPRESSION OF INTEREST FOR PROVISION OF PRODUCTION SUPPORT VESSEL (PSV) AT CB/OS-2 & RAVVA BLOCK**

Cairn Energy India Pty Ltd (CEIL) invites Expression of Interest from the Owners / Operators for charter hire of Production Support Vessel (PSV) to support its Offshore Facilities in the CB/OS-2 and RAVVA blocks (One vessel for each block) for a period of three years with charterer's option to extend by one year.

### **CB/OS-2 Block – Gulf of Cambay in the West Coast of India :**

CEIL is the Operator of the CB/OS-2 block located in the west coast of India, on behalf of Joint Venture Partners consisting of Cairn Energy India West B.V., Cairn Energy Cambay B.V., Cairn Energy Gujarat B.V., ONGC Limited, Tata Petrodyne Limited and CEIL.

The scope of work under this EoI for CB/OS-2 block is to provide a production support vessel which is capable of operating in shallow waters and high current areas. Basic specifications of the vessel shall be Twin Screw, IACS class, 2400 BHP, bow thrusters, deadweight min 400 MT, clear deck space 200 sqm, Fi- Fi class 1, oil-spill contingency equipment (spray booms, pumps / Proportionator), accommodation for min 6 personnel, 5T Crane and 12 Knots speed. **The age of the vessel shall be less than 15 years at the time of commencement of charter.** The contract period shall commence from **1<sup>st</sup> January 2013**

### **RAVVA Block – East coast of India**

CEIL is the Operator of Offshore Oil & Gas field "RAVVA" located in East coast of India, on behalf of Ravva Joint venture consisting of ONGC, Videocon Petroleum Ltd (VPL), Ravva Oil Singapore (ROS) and CEIL.

The scope of work under this EoI for Ravva block is to provide a production support vessel which is capable of operating in shallow waters. Basic specifications of the vessel shall include Twin Screw, minimum 2000 BHP, Bow thrusters, IACS class, Fully equipped for Four Point Mooring including anchors, winches & other accessories as necessary, clear deck space sufficient to accommodate dive equipment / spread for offshore projects and carry out diving activities, Minimum deck space 250 Sq m (25 m x 10 m) (Providing Dive Equipment & Dive Personnel is NOT part of this scope), capable for providing necessary support for offshore projects including maintenance of SPM buoy, SPS compliant for 49 personnel, 12 T Crane, Fi- Fi class 1, equipped with oil-spill contingency equipment (spray booms, pumps / Proportionator). **The age of the vessel shall be less than 15 years at the time of commencement of charter.** The contract period shall commence from **1<sup>st</sup> May 2013**.

Interested Companies, with minimum 5 years experience in oil & gas support vessel operation are requested to submit their expression of interest **separately** for CB/OS-2 and Ravva block with the

following documents within 14 days of publication of this advertisement. The Contractor must submit details for the following

1. Organisational outline proposal detailing their nominated management, staff, and business process support for the provision of the PSV.
2. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.
3. Company's turnover details
  - a) For Ravva Block : Bidders average turnover in the last three years should be US \$ 4.0 MM;
  - b) For CB Block : Bidders average turnover in the last three years should be US \$ 3.0 MM;
  - c) Bidders net worth should be positive;
4. Details of prior experience in support of Oil and Gas production activities
5. Details of proposed vessel & equipment and their availability.
6. Details and copies of ISO 9001 / ISM certification must be submitted. Contractor must have an appropriate comprehensive Health, Safety and Environmental management system in place which promotes, aligns with and upholds CIL's and the Contractor's HSE commitment.
7. Details of standard management, operating and maintenance procedures with copies of QA/QC certification.
8. Proof of ownership of Vessel
