

EXPRESSION OF INTEREST (EoI) FOR PROVISION OF CUSTOM CLEARANCE, TRANSPORTATION AND LOGISTICS SERVICES AT RAJASTHAN, GUJARAT AND ANDRA PRADESH

Cairn Oil and Gas, a vertical of **Vedanta Limited** is the Operator at onshore block RJ-ON-90/1 located in Barmer & Jalor Districts in the state of Rajasthan; Offshore block CB/OS-2; located off the west coast of the state of Gujarat; Offshore Block Ravva Oil and Gas Field (Ravva), located off the east coast of the state of Andhra Pradesh.

Operator on behalf of itself & Joint Venture (JV) partner(s) invites interested contractors with proven capabilities and demonstrated performance in similar requirement to express their interest for pre-qualification to participate in the Competitive Bidding Process for **the 'PROVISION OF CUSTOM CLEARANCE, TRANSPORTATION AND LOGISTICS SERVICES AT RAJASTHAN, GUJARAT AND ANDHRA PRADESH'**

Scope of Work broadly includes:

Checking and confirmation of documents required for custom clearance under EC, obtaining Essentiality Certificates and other statutory approvals, custom clearance, forwarding of the cargo, MOHA clearance, etc. for the company's routine operations, maintenance, projects, well construction and well services activities at various sites in Rajasthan, Gujarat and Andhra Pradesh.

Interested companies meeting following criteria should respond to this EoI:

1. Interested Companies shall have a minimum of three (03) years' experience (in preceding five (05) years) in providing Custom Clearance, Transportation and Logistics Services to Oil & Gas processing / Refining / Petrochemical / Chemicals / Thermal Power Plants / Mining / Metal / other Industries.
2. Turnover in each of the immediately preceding two financial years should be equal to or more than the estimated annual contract value.
3. Positive net worth in each of the immediately preceding two financial years.
4. Liquidity ratio in each of the preceding Two (02) financial years shall not be less than 0.60.

Bidder to indicate its interest in any of the following locations:

1. Rajasthan
2. Gujarat
3. Andhra Pradesh

Bidders are requested to submit the following pre-qualification documents as a minimum:

- ❖ Letter of interest clearly indicating the project reference and location of interest.
- ❖ Detail Company Information with Organisation structure.
- ❖ List of vehicles /assets / offices owned.
- ❖ Details of completion of similar type of projects in the last three years under heading:
 - a) Brief scope of work
 - b) Value of work in INR
 - c) Contractual Duration
 - d) Actual completion of Project
 - e) Clients name
 - f) Contact details of the Client (Cairn may approach the client directly for the feedback)
 - g) HSE statistics, LTI graph etc.
- ❖ Bidder shall provide contract copies of major contracts (Provision of Custom Clearance, Transportation and Logistics Services) executed in each of the preceding three years.

- ❖ Details of current commitments - List of all jobs under execution with the value of the Job and percentage completion.
- ❖ Service Completion Certificates, Client Feedback etc of similar contracts executed in the last three years.
- ❖ HSE policy and implementation procedures in line with internationally accepted practices with LTI statistics for last three years,
- ❖ Quality assurance & quality control practices currently in place for the execution of similar work.
- ❖ Company's financial performance documents (Audited Balance sheets and Profit and Loss statements, Auditors Report and Notes to Accounts etc.) for last 2 (two) years. Latest financial statement should not be older than 18 months on the date of submission of response to Expression of interest
- ❖ Documents in support of Health & Safety
- ❖ Environment & Quality [HSEQ] performance.
- ❖ Copies of ISO 9001, 14001, OHSAS 18001 or any other certification as applicable.

Also, note -

- i. Normally standalone financials of the bidding entity only will be considered. However, consolidated financials at the bidding entity level, if available, can also be submitted. Parent company or Affiliate's financials can be submitted and considered, subject to submission of Parent/ Affiliate company guarantee. This should be clearly mentioned in the EOI response.
- ii. Evaluation will be done only on the basis of the published annual reports / audited financials containing Auditor's report, Balance sheet, Profit & Loss a/c and Notes to Accounts.
- iii. In case of unaudited statements (if there are no audit requirements for auditing of financials as per the local law), the financials shall be accompanied by a certificate from a Certified Accountant. Certificate should also mention the fact that there is no requirement of audit of the financials as per the local law.

All qualifications and exceptions brought out in Auditor's report and Notes to Accounts would be factored in while undertaking financial evaluation
