
**EXPRESSION OF INTEREST (EoI) FOR PROVISION OF SURVEYING SERVICES FOR
CRUDE LOADING & UNLOADING OPERATIONS AND QA/QC SITE SUPPORT
SERVICES AT RAJASTHAN, GUJARAT AND ANDHRA PRADESH, INDIA**

Cairn Oil and Gas, a vertical of Vedanta Limited, is the Operator of onshore block RJ-ON-90/1 located in Barmer & Jalore Districts in the state of Rajasthan & crude oil/gas export cross country Pipeline from Barmer in Rajasthan to Bhogal in Gujarat; Offshore block CB/OS-2 located off the west coast of the state of Gujarat; Offshore Block Ravva Oil and Gas Field (Ravva), located off the east coast of the state of Andhra Pradesh.

Operator on behalf of itself & Joint Venture (JV) partner(s) invites interested contractors with proven capabilities and demonstrated performance in similar requirement to express their interest for pre-qualification to participate in the National Competitive Bidding (“NCB”) Process for the **‘Provision of Surveying Services for Crude Loading & Unloading Operations and QA/QC Site Support Services’**

Bidder to indicate its interest in any or all of the following categories of services and locations:

Services:

Part-A - Surveying Services for Crude Loading & Unloading Operations

The scope of work is to provide surveyor manpower for crude oil tanker loading and unloading operations and associated activities including safe liquid evacuation from satellite well pads, loading/unloading volume quantification, crude sampling, tanker liquid reconciliation, and ensuring best quality performance in Productivity, reliability, Integrity, safety, and cost at various COMPANY locations.

Part-B –QA QC Site Support Services

The scope of work is to witness the quality and quantity of crude oil/produced water transferred to COMPANY specified locations from each marginal oil field’s well pad across COMPANY’s Asset, manage tanker loading & unloading operations and associated activities including safe liquid evacuation from satellite well pads, loading/unloading volume verification, crude sampling, tanker liquid reconciliation, delivery challan certification and virtual trip creation on VTS system by supervising the third party contractors on site (Surveyor, HSE Personnel, Security and Site Operators) and ensuring best quality performance in Productivity, reliability, Integrity, safety, and cost.

Locations:

- Rajasthan
- Gujarat
- Andhra Pradesh

Interested parties meeting the following criteria should respond to this EoI:

Financials:

1. Turnover in each of the immediately preceding two financial years should be equal to or more than more than the estimated average Annual contract value.
2. Positive net worth in each of the immediately preceding two financial years.

3. Liquidity ratio in each of the preceding 2 financial years shall not be less than 0.60.

Technical:

For Part A -

Minimum Three (03) years' experience (in preceding 05 years) in providing Surveyor for Crude Oil / Liquid Hydrocarbon Loading & Unloading Operations to Oil & Gas processing / Refinery / Petrochemical / Chemical / Thermal Power Plant / Mining / Metal industries.

For Part B –

Minimum Three (03) years' experience (in preceding 05 years) in providing QA/QC Site Support services to Oil & Gas processing / Refinery / Petrochemical / Chemical / Thermal Power Plant / Mining / Metal industries.

Participants are requested to submit the following pre-qualification documents as a minimum:

1. Letter of interest clearly indicating their interest to participate for the services mentioned above under Part A & B and the location interest.
2. Detailed Company Information with Organization structure, List of manpower with CVs of key personnel and capability to execute job with clear responsibility & escalation matrix for Technical, HR & HSE Departments.
3. Details of completion of similar type of contracts in the last Five years (PO/Contract copies and Service Completion Certificate) and similar contracts/agreements currently under execution under headings:
 - a) Brief scope of work b) Value of work in INR c) Contractual Duration d) Actual completion of Project e) Clients name f) Contact details of the Client (Vedanta may approach the client directly for the feedback) HSE statistics, LTI graph etc.
4. Details of availability of Competent Manpower
5. Details of availability of all resources (Measuring instruments, hand tools and equipment)
6. Details of HSSEQ policies, Regulatory Compliance, Contractor HSE Induction, Environment Management, Health, Hazard Management, Incident Investigation & Analysis, Competency & Training, Integrity & Maintenance Management, Operating and Safe Working Procedures, Safety Awareness, Transport Management ,Security Management, Sub-Contractor Management etc.
7. Valid Quality Certifications/ Accreditations etc.
8. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements, Auditors Report and Notes to Accounts etc.) for last 2 (two) years. Latest financial statement should not be older than 18 months on the date of submission of response to Expression of interest.

Also, note –

- i. Normally standalone financials of the bidding entity only will be considered. However, consolidated financials at the bidding entity level, if available, can also be submitted. Parent company or Affiliate's financials can be submitted and considered, subject to submission of Parent/ Affiliate company guarantee. This should be clearly mentioned in the EOI response.
- ii. Evaluation will be done only on the basis of the published annual reports / audited financials containing Auditor's report, Balance sheet, Profit & Loss a/c and Notes to Accounts.
- iii. In case of unaudited statements (if there are no audit requirements for auditing of financials as per the local law), the financials shall be accompanied by a certificate from a Certified Accountant.

Certificate should also mention the fact that there is no requirement of audit of the financials as per the local law.

All qualifications and exceptions brought out in Auditor's report and Notes to Accounts would be factored in while undertaking financial evaluation
