GLOBAL EXPRESSION OF INTEREST FOR 3D LAND SEISMIC DATA REPROCESSING SERVICES

Cairn Energy India Pty Ltd. ("CEIL") is the Operator of the Rajasthan block RJ-ON-90/1, on behalf of the Joint Venture partners Cairn India and ONGC. CEIL is planning to commence Bhagyam field development activities in the Rajasthan Block RJ-ON-90/1, onshore block by September 2010.

CEIL seeks expression of interest (EOI) under International Competitive Bidding Process ("ICB") from suitably experienced seismic data processing contractors (both Indian and International) capable of carrying out this work in India, which broadly encompasses the following:

- Processing of 3D Pre Stack Time Migration (PSTM) or Pre Stack Depth Migration (PSDM) of land seismic data, using advanced seismic processing technique.
- An effective & detailed internal as well as remote QA/QC process will also be required.

With this EOI, CEIL intends to short list names of experienced Seismic Processing Contractors to invite for the tender for the 3D land seismic data reprocessing services.

This work must be carried out in India. The company shall necessarily be a seismic data processing contractor, shall have proven experience in similar types of seismic processing, and shall have sufficient personnel, equipment, management, effective QA/QC procedure and organizational processes to conduct the works. The company shall be able to demonstrate full understanding of Indian and internationally accepted Health, Safety and Environmental practices, procedures and policies. Only companies who can comply with these requirements and who can demonstrate a successful track record, listing projects, clients and client contacts which may be approached, should respond to this notice.

Companies are requested, as a minimum, to submit the following documents and details with their expression of interest:

- 1. Lists of similar work successfully executed in the last three years and projects currently under execution
- 2. Details of work conducted in similar terrain, ideally in India
- 3. Detail description of the basic processing flows, with optional proprietary processes.
- 4. An estimate for the duration of the project from receipt of field data and supporting documentation
- 5. Personnel details including bio-data of key personnel.
- 6. Available software and hardware details.
- 7. QA/QC procedure (internal and remote) details.
- 8. Description of project deliverables.
- 9. Location of project execution in India.
- 10. Health, Safety and Environment policies, procedures and statistics covering the last 4 years.
- 11. Corporate financial details.

Interested Seismic Contractors who can fulfill all of the specifics listed above shall submit their response including the details and references stated above, **within 7 days** of publication of this notice.
