**GLOBAL EXPRESSION OF INTEREST UNDER INTERNATIONAL
COMPETITIVE BIDDING (ICB) BASIS FOR PROVISION OF VESSEL
FOR ACID STIMULATION JOB AT RAVVA BLOCK**

Cairn India Ltd (CIL) is the Operator of Ravva block located on the east coast of India. CIL invites Expression of Interest from Owners/ Operators for charter hire of Vessel for supporting Acid Stimulation campaign at Ravva Block. The PSV will be required on a charter hire basis for a period of about 45 to 60 days. Expected date of hire is 15th December 2013.

The vessel shall be capable of operating in shallow waters. Basic specifications of the vessel shall be Twin Screw, IACS class, min 2400 BHP, bow thrusters, clear deck space 300 sqm minimum, ½ Fi- Fi, 5T Crane, 12 Knots speed, Passenger Accommodation for Minimum 12 person in 4 Cabins. Vessel shall be equipped with oil-spill contingency equipment and must have relevant statutory compliances and certificates through-out the period of hire.

Interested parties with minimum 5 years' experience in oil & gas support vessel operations should submit their expression of interest with the following documents and details which will serve as techno-commercial pre-bid qualification criteria within 15 days of publication of this advertisement.

Prequalification:

1. Letter of interest with detailed company information as follows:

- a) State the name of the parent Company
- b) State the name/address/phone/e-mail of the company that would execute the Contract
- c) If a Joint Venture to be proposed, state the name/address/phone/e-mail of all Joint Venture partners
- d) Organization structure
- e) List of Manpower with CV's of key personnel (Master, Chief Officer, and Stewards of Vessel) with all of them STCW certified as applicable.

2. Company's financial performance documents (including JV partner's financials, if proposed) i.e. Audited Balance Sheets, Profit and Loss Account & Cash Flow Statement for the last 3 year's & following details separately;

- a) The average annual turnover of the company for last 2 years should be \$3.5 mm
- b) Bidders positive net worth should be \$ 0.35 mm value for each of the last 2 years
- c) Liquidity ratio in last 2 financial years should not be less than 0.75.

3. Experience :

- a) Demonstrate minimum Five (5) years of experience of providing similar Vessels in Oil & Gas sector.
- b) Details of current commitments

4. HSE Systems:

- a) HSE Manual/Policy
- b) Project specific HSE Plan for similar project

5. Other Requirements

- a) Details of proposed vessel & equipment and their availability
- b) Equipment: Specifications of all equipment (inclusive of tackles, tools, instruments, spars and standby equipment etc.) with all valid certification and test details.
- c) Resources in India for Repair, Maintenance and Infield support of vessel
- d) Details of ISO 9001/ ISM certification
- e) Quality Assurance and quality control practices currently in place for the execution of similar work and accreditations.
- f) Proof of ownership of Vessel or concurrence from registered owners for intended job.
- g) Accidents / incidents statistics for past 5 years.
- h) Bidder to have good mobilization record for equipment and personnel. Past track record shall be submitted by the bidders.
