**EXPRESSION OF INTEREST (EOI) FOR CONSTRUCTION OF OPERATIONS
BASE NEAR BARMER, RAJASTHAN, INDIA**

Cairn Energy India Pty Limited (“CEIL”) is the Operator, on behalf of Joint Venture partners CEIL, Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation, of the Contract Area RJ-ON-90/1 in the state of Rajasthan. Subsequent to a successful oil discovery in the area, CEIL is in the process of developing the Northern Area Fields including Mangala Oil Fields and Raageswari Gas Fields.

CEIL invites expression of interest from reputed contractors with necessary experience for executing the construction of an Operations Base near Mangala Terminal in the Barmer area of Rajasthan which includes Civil, Architectural, HVAC and Mechanical, Electrical & Plumbing (MEP) services work.

SCOPE OF WORK

The scope of work broadly envisages the construction of the following facilities at the Operations Base:

- (a) Office Administrative Building, Medical Centre, Training Workshop, Bachelor Accommodation buildings without soft interior works, Kitchen service block and all utility services including Energy conservation and Environment friendly features;
- (b) External & Internal electrification works;
- (c) Water Supply distribution and sewerage system including storage tanks and internal fittings/ fixtures;
- (d) HVAC systems including laying of piping & ducting;
- (e) Area Development Works including pavements, storm water drainage, hard and soft landscaping excluding the roads; and
- (f) Mechanical, Electrical and Plumbing utility services for the Operations Base.

SCOPE OF SUPPLY

All the material required shall be supplied by the contractor as part of their scope, CEIL will not supply any materials. The Contractor shall have to make his own arrangements for storage, site office and labour camps for the entire job.

COMPLETION SCHEDULE

Completion schedule for the construction of the Operations Base buildings and its associated works shall be within 6 months of contract award.

Interested Contractors shall submit the following documents as a minimum with their EOI for pre-qualification:

- 1) Letter of interest with detailed company / construction information.
- 2) List of similar works executed in the last five years for leading Corporate/ Industrial House/ Class ‘A’ PSUs and work currently under execution, with at least one single contract for similar jobs of a value not less than Rs.25 crores. The list shall illustrate the quality and magnitude of the previous contracts relative to the subject requirement and the company’s demonstrated

expertise including project management techniques employed in those projects which it intends to utilise in this project.

Certificates of satisfactory completion of work must also be provided. The aspirants must have suitable experience of having executed works with comprehensive packages as mentioned above.

- 3) Company's financial statements / Audited Balance Sheet for the last 3 (Three) years of operation.
- 4) Information regarding any current litigation in which the Bidder is involved.
- 5) Bankers Certificate for credit worthiness.
- 6) List of contracts executed for CEIL in the past, if any.
- 7) Details of resources (nos. & CV of key personnel) and facilities including those to be provided at site for construction, project management etc. together with an indication of the facilities available in house and works that would be sub-contracted to third parties. Please provide names of sub-contractors you would normally use.
- 8) Complete administrative details of your Company such as but not limited to the nature of the legal entity, registration details, organization chart, office locations, site locations etc.
- 9) Details of Health, Safety & Environment (HSE) and Quality Assurance and Control (QA/QC) systems followed for similar contracts and certifications, if any.

CEIL reserves the right to accept or reject any EOI at any time without any liability to the applicants or any obligation to inform the applicants of the grounds for such rejection.
