

EXPRESSION OF INTEREST (EOI) FOR SELECTION OF CONTRACTOR FOR CAFETERIA MANAGEMENT SERVICE AT CAIRN OIL & GAS CORPORATE OFFICE LOCATED AT ASF CENTRE, GURGAON, HARYANA

Scope is inclusive of

- a. **Primary Location of Service-** The contractor shall be responsible for providing Cafeteria Service at ASF Tower A, Udyog Vihar, Gurgaon
- b. **Type of Menu-**
 - (i) **Fixed-** Provision of a fixed menu Buffet between 1200hrs to 1430hrs with minimum 5 course, plus accompaniments, Veg and Non -Veg options compulsory every day. A common price for Veg and Non-Veg buffet shall be fixed for the entire contract period.
 - (ii) **A la Carte-** Provision of a separate A la Carte counter for breakfast, lunch, and evening snacks. The rate list of the items available on a particular day shall be as agreed in the contract. Any changes must be mutually acceptable between the service provider and the Company.
 - (iii) Provision for supplying and availability of imported dry fruits, cookies, exotic cut fruits and fresh juices.

Detailed scope of work will be shared with the qualified bidders.

Following are pre-qualification criteria for bidding for this tender:

1. Bidder should have minimum 10 years of experience in the catering business, out of which at least 05 years' experience should be in managing the cafeteria Service of large corporate (Attach valid copy of purchase/work order/contract along with completion certificate/ contract closure letter from the client/customer)
2. Bidders should have a valid FSSAI certificate, kindly share relevant supporting documents.
3. Service provider should have tie-up with recognized/renowned Food Laboratory.
4. The Bidder shall submit valid documentary proof of GST Registration and Income Tax Registration number (PAN). (Attach valid documentary proof in this regard)
5. The Bidder should be in existence for at least the last three financial years. (relevant documentary proof to be submitted)
6. Head / Registered / Corporate Office / Branch Office/Running Kitchen Facility should be in Delhi / NCR (relevant documentary proof to be submitted)

Interested Bidders who fulfil the above criteria shall submit their response with the following details within 07 days of the publication of this EOI.

1. Bidder's Company profile, Organization set-up
2. Last 3 years audited financials along with relevant supporting documents.
3. The bidder should not be under liquidation, court receivership or similar proceedings, and should not be bankrupt. (Attach self-declaration by the bidder on its letterhead duly signed & stamped)
