**GLOBAL EXPRESSION OF INTEREST FOR SUPPLY OF REMOTE OPERATED SHUT OFF VALVES (ROSOVs) FOR RAJASTHAN BLOCK**

Cairn India Ltd (“CIL”) is the Operator of the Onshore **RJ-ON-90/1** block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major Oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

CIL intends to install Remote Operated Shut off Valves (ROSOVs) to the hydrocarbon storage tanks. The valve sizes required are various from 2” to 30” NB with 150# rating. The materials, design, fabrication, testing and workmanship shall comply with the relevant standards, specifications & codes. The ROSOV shall be having a PTR for the similar applications. The ROSOVs are designed, engineered and supplied equipment/ system shall be suitable for the desert, high ambient temperature with wind storm site conditions.

The scope of work shall be Supply of:

- Remote Operated Shut off Valve (ROSOVs)

**Only those Suppliers meeting the following criteria as a minimum should respond to the EOI:**

- Supplier should be the manufacturer of Remote Operated Shut off Valve and having minimum 3 years of experience in supply in Oil & Gas industry.
- Supplier turnover for last Two (2) audited years should be more than i.e. USD 3 MN.
- Supplier’s net worth should be more than \$ 0.3 MN for last Two (2) audited years.
- Liquidity ratio in each of the preceding years shall not be less than 0.75.

Companies are requested, as a minimum, to submit the following documents and details:

1. Detail Company information with Organization structure, Parent company, Plant & machinery list mentioning year of manufacture, support agencies and other facilities and resources.
2. List/ Details of similar type of Supply successfully executed for minimum 3 years and similar Supply currently under execution under headings a) Brief scope of work b) Value of work c) Contractual duration d) Actual completion of project e) Client name f) Contact details of client (CIL may approach the client directly for feedback) with the completion certificates, PO, LOI or contract Copies.
3. Client reference list.
4. Supplier shall submit financial audited statement for the year FY-12 and FY-13.
5. HSE Certification OHSAS 18001.
6. Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work, Copy of ISO 9001 and 14001 or any other certification as applicable.
7. Sales and Service in India.
