Cairn Energy India Pty Ltd (CEIL) is the Operator of Ravva and CB/OS-2 oil and gas block located on the east and west coasts of India.

CEIL invites expression of interest from experienced Contractors for provision of the following services on long term on Call Out basis.

### **(1) Provision of Vessel Supported Hydraulic Work Over Services**

Supply of Hydraulic Work over (HWO) services including the provision of all equipment, personnel and materials required to carry out vessel supported HWO operations on offshore satellite platforms including but not limited to; well kill, pulling/running completion and work strings, fishing and milling, sidetracking, perforating, sand control and cementation.

The scope of supply will include the all equipment, materials and services associated with the intervention and workover operations as well as the provision of a suitable support vessel and crew.

The equipment package, and specifically the support vessel, should be capable of continuous and efficient operations in the planned environment(s) during the annual inclement weather windows that these locations experience.

The above EOI is also applicable for companies dealing with only HW services or support vessel services. However companies applying against Support vessel services should demonstrate previous experience with similar operations.

### **(2) Provision of barge supported Coil Tubing services**

Supply of Coil Tubing Unit (CTU) services including the provision of all equipment, personnel and materials required to carry out barge supported CTU operations on offshore satellite platforms including but not limited to; cleanout sand fill, stimulation treatments, tubing cutting, fishing and sand control operations. The operations will require a floating barge support due to space constraints on the unmanned platforms in the given assets.

The scope of supply will include the all equipment, materials and services associated with the intervention and workover operations.
