### **EXPRESSION OF INTEREST (EOI) FOR EPC (ENGINEERING, PROCUREMENT AND CONSTRUCTION) WORK TO ENHANCE TELECOMMUNICATION SYSTEMS ALONG THE PIPELINE & TERMINALS FOR MANGALA DEVELOPMENT PIPELINE PROJECT (MDPP)**

Cairn India Limited ("CIL") is the Operator on behalf of Joint Venture partners Cairn Energy Hydrocarbons Limited and Oil and Natural Gas Corporation, of the Contract Area **RJ-ON-90/1** at Barmer in the state of Rajasthan. The RJ-ON-90/1 Block contains oil discoveries including the Mangala field, the largest onshore oil discovery in India since 1985.

CIL has set up and commissioned a ~ 670 km long pipeline, pumping stations, terminals and related facilities for the transportation of 1,50,000 to 1,75,000 barrels of crude oil per day from the upstream process terminal at the Mangala field to the downstream terminal point on the Gujarat coast at Bhogat in Jamnagar District.

Cairn India Limited (CIL) proposes to enhance the bandwidth of existing telecommunication network along the facilities (pipeline & terminals) and to provide additional telecommunication hardware's for upcoming Bhogat Terminal. The Telecommunication systems shall consist of all necessary hardware & software, auxiliary equipment and all appurtenances that are required to enhance existing telecommunication facility along the operational facility with minimum downtime to a safe and fully operational system.

CIL on behalf of its joint venture partners invites reputed (EPC) Engineering, Procurement and Construction suppliers with demonstrated HSE performance to express their interest to participate in pre qualification as bidders and to participate in competitive bidding process. In view of the nature of the scope, only those suppliers possessing the requisite and proven record of performance in executing at least 02 similar jobs of value exceeding USD 1 Million in last 3 Years should respond to this notice.

Only those companies possessing substantial and proven record of performance in executing similar jobs of this magnitude should respond to this notice. Companies are requested, as a minimum, to submit the following documents and details:

1. Letter of interest with detailed Company information with Organisation structure, List of manpower with CVs of key personnel, Plant and Machinery list mentioning year of manufacturing, Support agencies and other facilities & resources.
2. Details of completion of similar type of projects in the last 3 years as minimum, preferably dealing with Oil and Gas Projects, exploration or refineries and petrochemicals.

3. List of all jobs under execution with the value of the Job and percentage completion.( With particular emphasis on project of similar magnitude carried out in Oil and Gas Sector)
4. Typical Project Planning and Execution methodology.
5. Should be profit earning firm/company for at least three preceding years.
6. Should never have been blacklisted by Government/PSU/CEIL/Reputed Company.
7. Should be registered with state service tax authority.

8. HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years.
  9. Should follow all HSE and Road Safety Policies of CEIL strictly.
  10. Quality assurance & Quality control practices currently in place for the execution of similar work/services.
  11. Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years.
  12. Details of Particular experience of providing Services in remote areas where rapid mobility and flexibility to accommodate CIL's programme is paramount. Evidence supporting successful major operations in remote areas must be submitted.
  13. Copies of any additional certifications.
