GLOBAL EXPRESSION OF INTEREST (EOI) UNDER INTERNATIONAL COMPETITIVE BIDDING (ICB) BASIS FOR PROVISION OF HELICOPTER SERVICES AT RAVVA

CEIL intends to award a contract for provision of Helicopter Services at Ravva oil & gas field, through an International Competitive Bidding Process. To this effect CEIL seeks Expressions of Interest (EOI) for the above Services for a period of three (3) years with provision of extension for 1 year.

SCOPE OF SERVICES

The Scope of Service will include but not be limited to the provision of technical support, equipment and personnel as necessary for provision of helicopter support services, including passenger and freight handling for transportation of:

- a) Company's personnel and others as may be directed by the Company; and
- b) Freight, which is the property of Company and others, to be carried internally (200 kilos of freight or externally under slung load (1000 -1200 kg)

Helicopters should be twin engine, twin pilot, IFR instrumentation, 9+2 pax, SAR capable and having under sling capability.

Interested contractors having a minimum of 1 year relevant experience in an offshore environment may submit their expression of interest with the following documents within 14 days of publication of this advertisement

1. Company profile, including details on experience
2. Details of Helicopters owned and available and mobilization schedule
 - The bidder should have fleet of helicopters in good flying condition and should be in possession of at least two (2) numbers of helicopters of the same type or equivalent as that of offered one.
 - Proposed Helicopters type/model
3. Experience
 - Lists of similar projects successfully executed
 - Helicopter should not have previous accident history
 - Details of current commitments
4. HSE Systems:
 - For all projects executed in last 5 years
 - HSE Manual/Policy
 - Project specific HSE Plan for similar project
 - Details on QA/QC and HSE systems
5. Company's financial performance documents (including JV partner's financials, if proposed) i.e. Audited Balance Sheets, Profit and Loss Account & Cash Flow Statement for the last 3 years & following details separately;
 - Company's financial performance documents (Audited Balance sheets and Profit and Loss statements etc.) for last 3 years
 - The average annual turnover of the bidder in last 3 years shall be as follows:
 - a. Domestic bidders : The average annual turnover shall be INR 45 cr in last 3 years

- b. Foreign bidders : The average annual turnover shall be USD \$ 8.4 mm in last 3 years
6. Net worth of the bidder should be positive as per the last audited financial year
 7. Ownership details (whether potential bidder intend to operate the CEIL offshore helicopter service themselves – or sub contract all or part of the operation to another helicopter operator?)
 8. Previous offshore operating experience within India; Are the helicopters currently in India – Yes/No?
 9. Capability for mobilization and time required for bidder to mobilize if awarded tender (max. 30days)
 10. Company to provide documents to prove their capability to repair, maintain and provide technical support of aircraft after commencement of work
 11. Letter of interest with detailed company information as follows:
 - State the name of the parent Company
 - State the name/address/phone/e-mail of the company that would execute the Contract
 - If a Joint Venture to be proposed, state the name/address/phone/e-mail of all Joint Venture partners
 - Organisation structure
 - Size of Departments
