### EXPRESSION OF INTEREST FOR SCAFFOLDING SERVICES INCLUDING ERECTION & DISMANTLING FOR RAJASTHAN BLOCK

Cairn India Ltd ("CIL") is the Operator of the Onshore RJ-ON-90/1 block, on behalf of itself and its Joint Venture (JV) partners Cairn Energy Hydrocarbons Limited (CEHL) and Oil and Natural Gas Corporation Limited (ONGC), located in Barmer district, in the state of Rajasthan, India. The Block contains number of major oil discoveries, including the Mangala, Bhagyam and Aishwariya Fields.

Cairn India Ltd in JV with ONGC is operating an onshore oil and gas processing facility known as Mangala Processing Terminal at Nagana village near Kawas about 25 kms from Barmer, Rajasthan for processing of crude from its eighteen nos of well pads, Bhagyam & Aishwariya (developing) well pads. Rageshwari gas terminal (RGT) is deep gas processing Terminal and located at around 80 Km from Mangala processing terminal (MPT).

CIL seeks Expressions of Interest (EOI) for Scaffolding Services including Erection & Dismantling for Rajasthan Block. Contract period shall be for 2 years & extendable up to 6 months.

CIL on behalf of itself and its joint venture partner's invites interested contractors with proven capabilities and demonstrated HSE performance to express their interest for pre-qualification to participate in the bidding process to perform Scaffolding Services Including Erection & Dismantling at Mangala Processing Terminal, Bhagyam well pads, Aishwariya oil field, Raageshwari Gas Terminal, Raag oil, and Saraswati and future Guda developments. in line with best industrial practices and standards.

#### Work Overview

The contractor is responsible for scaffolding work with all materials as per requirement of CIL.

- To carry out scaffolding at various locations as per requirement of CIL, stages of scaffolding vary as per necessity.
- Scaffolding pipes shall be of all the lengths as per site requirements.
- All installations and execution should be in line with Cairn HSE & QA/QC policy.
- Good housekeeping at the workplace during and after completion of works.
- Stacking and storage of pipe & clamps will be done at designated areas only.
- Contractor should follow OSHA 1926.452 scaffold standard.
- Rubber pads/plugs/Caps to be provided to cover tube end points to avoid any harm from sharp edges.

#### Financial Criteria

- ❖ Turnover in each of the immediately preceding two financial years should be equal to or more than the estimated average annual contract value.
- ❖ Positive net worth in each of the immediately preceding two financial years.
- ❖ Liquidity ratio in each of the preceding 2 financial years shall not be less than 0.60.

#### Technical Criteria

- ❖ Bidder should have experience in providing scaffolding services for a minimum of 3 years in the field of Oil & Gas, Refinery, Petrochemical and Utilities System

Bidders are requested, as a minimum, to submit the following documents and details:

- ❖ Letter of interest clearly indicating the project reference
- ❖ Detail Company Information with Organisation structure, List of manpower with CVs of key personnel, Plant and Machinery list mentioning year of manufacturing, Support agencies and other facilities & resources.
- ❖ Details of completion of similar type of projects in the last three years under heading:
  - a) Brief scope of work b) Value of work in INR c) Contractual Duration d) Actual completion of Project
  - e) Clients name f) Contact details of the Client (CIL may approach the client directly for the feedback)
  - g) Safety certification / Inspection of plant and machineries h) HSE statistics, LTI graph etc.
- ❖ Typical Project planning and Execution methodology
- ❖ Past Track record of similar works executed list with Work order, P.O Copies or LOI copies and Client completion certificates.
- ❖ Details of current commitments - List of all jobs under execution with the value of the Job and percentage completion (with particular emphasis on project of similar magnitude carried out in Oil and gas sector)
- ❖ Experience of working in similar terrain.
- ❖ HSE policy and implementation procedures in line with internationally accepted practices with statistics for last four years,
- ❖ Quality assurance & quality control practices currently in place for the execution of similar work.
- ❖ Bidders are requested to submit their financial performance documents (Audited balance sheets and Profit & Loss statements) and Audit Reports for last 2 preceding years.
- ❖ Company registration details, Pan card, Service tax CST / VAT, details.
- ❖ Documents in support of Health, Safety, Environment & Quality [HSEQ] performance
- ❖ Copies of ISO 9001, 14001, OHSAS 18001 or any other certification as applicable.
